

Jurisprudence Module

The purpose of the NANB Jurisprudence Module is to develop and measure awareness and understanding of key legislation and the regulatory framework that govern nursing practice in N.B.

Registration Requirement

Completion of the jurisprudence module is a mandatory registration requirement for initial NANB applicants, and for reinstatement of registration.

Module Components

The jurisprudence module includes two components:

- 1) the jurisprudence learning component
- 2) the jurisprudence testing component
 - □ RN/NP General Requirement for all RN and NP applicants
 - □ NP Specific Additional requirement for NPs only

Jurisprudence Learning Component

The Jurisprudence learning component is self-guided. The applicants must review the content and listed resources identified in the Jurisprudence Study Guide to prepare for the jurisprudence testing component.

Jurisprudence Testing Component

The Jurisprudence testing component assesses the applicant's knowledge and understanding of nursing regulation, nursing standards, and provincial and federal legislation that govern nursing practice in N.B.

The Jurisprudence test is an open book online test that consists of multiple choice, true/false, matching, and drag/drop questions. Once applicants have submitted their application to register with the NANB and paid the application fee, details to access the study guide and testing component will be provided.



The general testing component must be completed by all RN and NP applicants. All NP applicants must also complete the NP specific testing component. All RNs who are applying to register as an NP and have previously completed the jurisprudence module are required to complete the NP testing component.

There is no time limit to completing the test. However, with the large amount of material to be revised, it is strongly recommended that applicants review the study guide content and related resource documents before completing the testing component. The test is designed to be completed individually.

The pass score is 80%. All applicants must obtain a successful mark to be able to complete the registration process with the NANB. Applicants who fail to obtain a pass score will be required to recomplete the test until successful, to continue the registration process. There are no limits on the number of attempts.
